**DESCRIPTION****Composition**

4.5g/day of this product contains 2.6g of a dried JP Hangekobokuto extract of the following mixed crude drugs.

JP Pinellia Tuber.....	6.0g
JP Poria Sclerotium.....	5.0g
JP Ginger.....	1.0g
JP Magnolia Bark.....	3.0g
JP Perilla Herb.....	2.0g

(JP: The Japanese Pharmacopoeia)

It also contains Lactose Hydrate, Corn Starch, Microcrystalline Cellulose, Partly Pregelatinized Starch, Light Anhydrous Silicic Acid as inactive ingredients.

**Product Description**

This product is fine granules, brown color, it has characteristic smell, and it tastes pungent and a little bitter.

**INDICATIONS**

The following symptoms of those patients who have anxiety, blocked feeling from the throat to chest, epigastric discomfort, insomnia, phobia, anorexia, coughing, etc.:

Bronchial asthma, bronchitis, pertussis, hyperemesis gravidarum, hoarseness, gastric neurosis, climacteric neurosis, nervous pharyngalgia, and neurosis

**DOSAGE AND ADMINISTRATION**

The usual adult dose is 4.5g/day orally in 3 divided doses before or between meals. The dosage may be adjusted according to the patient's age and symptoms.

**PRECAUTIONS****1. Important Precautions**

- (1) When this product is used, the patient's "SHO" (constitution /symptoms) should be taken into account. The patient's progress should be carefully monitored, and if no improvement in symptoms/findings is observed, continuous treatment should be avoided.
- (2) When this product is coadministered with other Kampo-preparations (Japanese traditional herbal medicines),etc., attention should be paid to the duplication of the contained crude drugs.

SHO: The term "SHO" refers to a particular pathological status of a patient evaluated by the Kampo diagnosis, and is patterned according to the patient's constitution, symptoms, etc. Kampo-preparations (Japanese traditional herbal medicines) should be used after confirmation that it is suitable for the identified "SHO" of the patient.

**2. Adverse Reactions**

This product has not been investigated (drug use investigations, etc.) to determine the incidence of adverse reactions. Therefore, the incidence of adverse reactions is not known.

**3. Use in the Elderly**

Because elderly patients often have reduced physiological function, careful supervision and measures such as reducing the dose are recommended.

**4. Use during Pregnancy, Delivery or Lactation**

The safety of this product in pregnant women has not been established. Therefore, the product should be used in pregnant women, women who may possibly be pregnant only if the expected therapeutic benefits outweigh the possible risks associated with treatment.

**5. Pediatric Use**

The safety of this product in children has not been established. [Insufficient clinical data.]
